### Cargo due

Please contact the Port Authority for clarification regarding the classification of the type of goods. The cargo due applies to all goods transported by ship to or from the port. Bulk goods are converted to weight in ton, where 1 m<sup>3</sup> cannot be less than 0.5 tons. Except for timber where 1m<sup>3</sup> is considered not less than 0.8 tons.

### ISPS – fee

Vessels calling at Trondheim Port Authority’s public quays are subject to an ISPS fee. The ISPS fee covers costs of all security measures during a call including staff, gates, fences and other equipment as well as administration. Vessels that pay ISPS-fee per passenger do not pay ISPS-fee per tonnage.

Measures that result in increased costs for a port call, e.g., to maintain hygiene requirements, infection-free quays, other extra costs related to safety measures, or the like, will result in increased charges for the port call in question.

### Waste disposal charge

Pursuant to the Regulations relating to Pollution Control (FOR 2004-06-01 no. 931), Chapter 20, the Port of Trondheim has established facilities for the disposal of waste and cargo residue from ships.

All vessels calling at public quays will be charged for waste disposal services, regardless of whether or not they deliver waste to the disposal facilities.

\*The charge applies to the handling of small amounts of waste related to cruise passengers within the quay area.

Exemption from the charge are vessels that have a valid waste delivery agreement in another port.

Naval ships and cruise ships are exempt and have to order waste disposal services directly with a recycling company through their agent.

## Use of landside port property

### Short term storage

Goods that are charged with a cargo due may be stored on our quays for up to 24h before loading and up to 24 h after loading. Thereafter charges occur per day (24hrs). For cargo that is stored more than 4 weeks or require more than 500m2 an individual contract needs to be signed.

### Turnaround due

When cruise ship passengers start or finish their cruise in Trondheim, a turnaround due will be charged in addition to the ISPS fee. The amount of the due is subject to negotiation.

## Services provided by others

Entities other than the Port of Trondheim can perform services in the port area. This requires an agreement with the Port of Trondheim.

### Use of mobile cranes and wheeled vehicles

Prices apply to work performed on the quay surface. Notification must be given to the Port Authority at the start and end of work. Violation of notification leads to a charge equivalent to 1 day, in addition to the time spent.

# Environmental incentives/Attachments

## Environmental Ship Index

Vessels in the category “other vessels” that hold a valid ESI-score from the Environmental Ship Index (ESI) of the World Ports Climate Initiative can get a discount on the fairway due.

ESI-score between 30 and 50 = 20% discount

ESI-score more than 50 = 30% discount

## Environmental Port Index

The Port of Trondheim uses the environmental index EPI (Environmental Port Index) for pricing of fairway due and quay due for cruise ships.

The cruise ship must have submitted its data within 72 hours after departing the port. Cruise ships that do not meet this requirement receive an EPI score equal to 0.

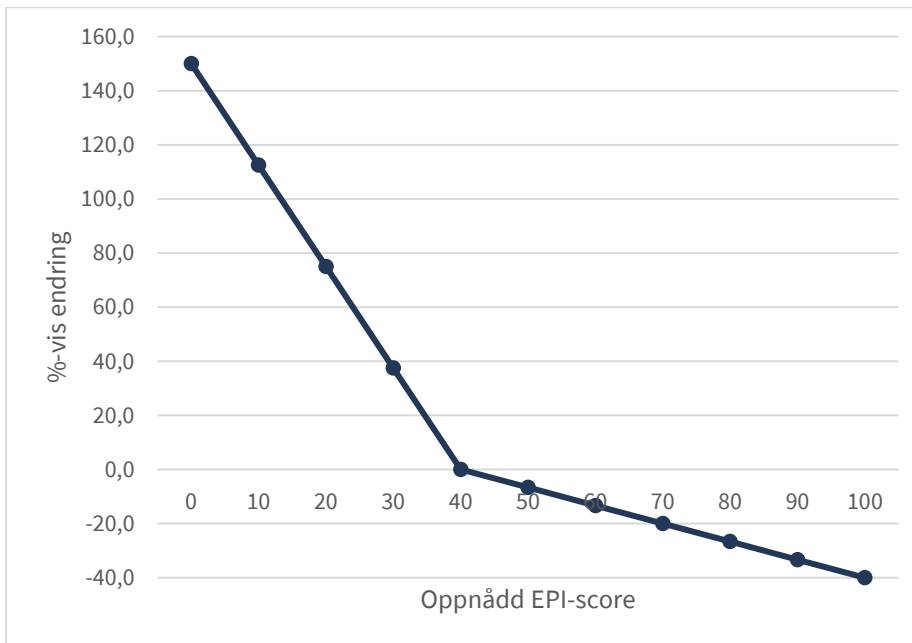
For the determination of fairway due and quay dues, the following calculation is used.

For EPI scores **below 40**:

$$\% \text{-wise change} = \% \left( \frac{1,5}{40} (40 - \text{EPI Score}) \right) 100$$

For EPI scores **above 40**:

$$\% \text{-wise change} = \% - \left( \frac{0,4}{60} (\text{EPI Score} - 40) \right) 100$$
