

General terms and conditions

The following commercial terms and conditions apply for Trondheim Port Authority (TPA) unless otherwise provided by law and related regulations or decisions. No liability is accepted for misprints.

Ordering quay and service

In order for Trondheim Port Authority to grant you docking rights a formal request needs to be sent including previous harbour, next harbour, security level of the vessel, waste declaration, intention to load and unload goods and invoice receivers. It is necessary to announce expected arrival time (ETA) at Trondheim harbour latest 24 hours in advance.

Trondheim Port Authority can provide the following services upon request that have been sent to TrondheimPort Authority by latest 12 am the previous day such as security, towing, water supply and mooring. Services are provided according to available capacity.

From 01.01.2022 quay allocation does not follow the first-come first-serve rule anymore. Attribution of the quay facility will be done according to size, security and additionally, emission reducing

Duty to provide information

Trondheim Port Authority can demand a copy of documentation to fulfil public requirements to keep statistics. This includes all information and documentation necessary to control, calculate and collect fees.

Conditions for Fairway due

Vessels calling within Trondheim Port Authority's port areas are subject to a fairway due. The fairway due is calculated using the vessel's gross tonnage (GT) as stated in the vessel's tonnage certificate, pursuant to the International Convention on Tonnage Measurement of Ships of 1969.

The fairway due finances the Port Authority's responsibility for safety in the port and water areas cf. §36 of the Act relating to Harbours and Fairways the Harbour Act.

Conditions for Quay due

Vessels calling at Trondheim Port Authority's public quays are subject to a quay due. The quay due is calculated using the gross tonnage (GT) of the vessel.

Quay dues are payment for the use of Trondheim Port Authority's quays, and are paid according to the length of stay, although never less than for 24 hours. The length of stay is defined as the time between berthing and unberthing, and is broken down to number of days. Six hours or less on a consecutive day will be counted as half a day.

The quay due is charged to enable future infrastructural investments as well as maintenance and use of existing quays. Furthermore, planning, logistics, external communication and welcoming facilities are coordinated in connection to each call.

ISPS fee

Vessels calling at Trondheim Port Authority's public quays are subject to an ISPS fee. The ISPS fee is calculated by the total number of passengers. The ISPS fee covers costs of all security measures during a call including staff, gates, fences and other equipment as well as administration.

Prices 2026

All prices quoted in this document are stated in Norwegian kroner (NOK) and are VAT exclusive.

Fairway and Quay due

Quay due: 0.85 NOK per GT The minimum quay due is NOK 12.000 Fairway due¹: 0.12 NOK per GT

SUM due: 0.97 NOK per GT

The total due is determined by the vessels EPI (Environmental Port Index) score.

Total due = 0.96 x GT + ((0.96 x GT) x EPI mark-up in %)

Calculate mark-up if EPI-Score is **NOT** 40:

If the vessel did not send in data within 72 hours after the call to get an EPI-score, the score is set to: $\bf 0$

Since May 2019 an online portal is available to enter the data that calculates your score. Technical data about the vessel must only be submitted once for all participating Norwegian ports.

Discounts

The following discounts apply on quay dues:

Seasonal discount:

Cruise ships calling during off-season get 20 % discount. The season for cruise ship calls is 1st May to 30th September.

Frequency discount:

Any cruise line (operating under the same brand name) calling several times within the same calendar year is entitled to a 5% discount on the 5^{th} and all subsequent calls. From the 10^{th} and all subsequent calls, the cruiseline is entitled to a 10% discount.

Accumulated discounts cannot exceed 20%. There are no discounts on the minimum amount.

Passenger fee

Passenger fee is **8.5 NOK** per passenger per call.

The passenger fee is not charged if passengers are not allowed to disembark according to national and local regulations.

Tender due

If you are anchored and use the tender facilities a fee of 6 000 NOK per day is charged.

This is to cover administration, planning, logistics, external communication and welcoming facilities that need to be coordinated.

Cancellation fee

When cancelling a cruise call, the following fee applies:

Cancellation within the same calendar year of the booked ETA, 30% of the guay due is charged.

In case of cancellation within 48 hours before the ETA, 100% of the quay due is charged.

Already incurred costs related to the call will be charged.

In case of cancellation due to force majeure, within 48 hours before ETA, no fee is charged.

Turnaround fee

When cruise ship passengers start or finish their cruise in Trondheim, a turnaround fee will be charged in addition to the ISPS fee. The amount of the fee will be set in cooperation with the ship agent.

Container gangway solution with frame



Garbage disposal

Garbage fee per call: 375 NOK to cover for garbage disposal for the guests within the ISPS-area.

Optional waste disposal: Waste declaration must be submitted no later than 24 hours before arrival and by 12 PM on Fridays for arrivals during the weekend. Orders received later are considered urgent and may incur a surcharge.
